





THE PILGRIMAGE

CAN YOU BE AN ANGEL OR AN ARCHANGEL?

Are you able to help support a young person by being an "Angel" or "Archangel"? Your financial support will help a young person have a wonderful spirit filled week away, where they will be able to encounter God and grow their faith and discipleship alongside others their age. An angel is an individual, an archangel is a church community.

ANGEL AND ARCHANGEL COMMITMENTS

One of the greatest and most privileged things an angel can do is to pray for the pilgrimage as a whole, and especially for one pilgrim. This is all we ask and for a minimum contribution of £40 you will be allocated a pilgrim to pray for. Similarly, archangels are church communities who agree to pay a minimum contribution of £300 towards the pilgrimage, and also agree to pay.



The pilgrim/s the Angels and Archangels have sponsored will send you a postcard during their week on pilgrimage. Part of their week will involve writing prayers for you and leaving them at the shrine of St David. You will also be invited to the final act of worship which will be lead by the pilgrims in the cathedral at the end of the pilgrimage. In addition, Archangels will receive a visit to their church from the pilgrimage team and some of the pilgrims in the months following the pilgrimage, to give feedback and encouragement to the archangel community.

NEXT STEPS

To become an Angel or Archangel you will need to complete the attached form and make the appropriate minimum payment either by cheque or by direct bank transfer.

Boost your donation by 25p of Gift Aid for every £1 you donate. Gift Aid is reclaimed by the Diocesan Board of Finance from the tax you pay for the current year. Your address is needed to identify you as a current UK taxpayer
